Safety Tips – Toolbox Topic: SAFETY DURING CONCRETE AND MASONRY CONSTRUCTION

All construction workers should be alert to the potential hazards associated with concrete and masonry operations. Among the most critical *unsafe* practices are:

- premature removal of formwork;
- failure to brace masonry walls;
- failure to adequately support precast panels;
 - inappropriate operation of equipment;
- failure to guard the end of reinforcing steel;
- inadequate shoring, which can lead to formwork collapse.


